- Candidates need to be fluent in English
- Candidates must be enrolled in a Master Program in Physics.
- · Candidates must have documented research experience on dark matter
- Candidates must be available to start immediately (EU passport or, in the case of non-EU citizens,
  a Greek student visa must be already issued and valid at the time of application)

The aforementioned required qualifications will be judged as follows:

- 1) Certificate of current enrollment in a master's program (yes/no; disqualification in case of no)
- 2) Copy of EU passport or, in the case of a non-EU citizen, copy of a valid a student visa (yes/no; disqualification in case of no)
- 3) Degree titles (1-10, 40% of total score)
- 4) Dark matter research experience (1-10, 60% of total score)

Applications will be evaluated by a three-member evaluation committee. In case of interview procedure, applicants will be invited to participate in person or teleconference.
