Required qualifications

- Candidates need to be fluent in English
- Candidates must be enrolled in a Master Program in Physics.
- Candidates must have documented research experience on Galactic magnetic fields.
- Candidates must be available to start immediately (EU passport or, in the case of non-EU citizens, a Greek student visa must be already issued and valid at the time of application)

The aforementioned required qualifications will be judged as follows:

- 1) Certificate of current enrollment in a master's program (yes/no; disqualification in case of no)
- 2) Copy of EU passport or, in the case of a non-EU citizen, copy of a valid a student visa (yes/no; disqualification in case of no)
- 3) Degree titles (1-10, 40% of total score)
- 4) Galactic magnetic field research experience (1-10, 60% of total score)

Evaluation procedure

Applications will be evaluated by a three-member evaluation committee. In case of interview procedure, applicants will be invited to participate in person or teleconference.

The results of the selection will be announced on the website of IA-FORTH.
