- 3) Candidates need to have experience with physics of accretion discs around compact objects.

Evaluation procedure

Applications will be evaluated by a three-member evaluation committee. In case of interview procedure, applicants will be invited to participate in person or teleconference.

The results of the selection will be announced on the website of IMBB-FORTH.
