**Title:** Optical spectra analysis and object classification in the framework of multi-wavelength data studies of sources in the SMILE data sample.

#### **Job Description**

Postdoctoral position in multi-wavelength (radio, optical, and X-ray) data analysis.

The candidate is required to analyse optical spectra of a large number of sources in the SMILE sample, with the goal of obtaining redshift measurements and classifying the type of objects. Multiwavelength data (radio and X-ray) studies will be also performed on sources that have been previously judged as genuine milli-lens candidates.

#### **Required qualifications**

\* The successful candidate needs to have a PhD degree in Astronomy (or completed all requirements for the degree), a good knowledge of active galaxies (agn) physics, and past experience on multiwavelength data analysis.

- Scientific publications relevant to agn physics and multiwavelength studies in international scientific journals (40%)
- Experience in multiwavelength data analysis (40%)
- Experience with programming languages (20%)
